## WHAT DOES THE COALITION DO?

- Facilitates dialogue, partnerships and events focused on prisoner reentry in Anchorage.
- Promotes Coalition member programs and services.
- Raises awareness, educates, and advocates for sound reentry approaches.
- Partners with other community organizations to address common issues and challenges.
- Conducts in-reach inside correctional facilities to help connect inmates to services in the community.
- Provides case-management services to eligible individuals returning to the Anchorage community.

In FY 2018, nearly 50% of all inmates released from Alaska DOC facilities were released to Anchorage.

## COALITION MEETINGS

The Coalition holds quarterly meetings which are open to the public and any interested parties. General Coalition meetings are held in the mornings at NeighborWorks Alaska.

Work Group meetings occur on a monthly basis and are led by Coalition member organizations/agencies. Work groups and subcommittees are action-oriented and focus on specific topics, such as housing, employment, peer support, and healthcare. ## WHO IS THE COALITION?

The Anchorage Reentry Coalition is comprised of a diverse group of more than 45 programs, agencies, and individuals engaged in prisoner reentry and recidivism reduction efforts in Anchorage and Alaska.

Members of the Coalition represent local and state agencies, non-profits, faith-based organizations, and private companies that reflect employment, housing, substance use treatment, mental health, veteran's services, primary care, advocacy, public safety, wrap-around social services, and more.

The Coalition is comprised of a Tri-Chair system, a Steering Team, and the general Coalition body, all of whom participate voluntarily. There are two funded positions associated with the Coalition: the Coalition Coordinator and the Coalition Case Manager.

The Coalition Coordinator oversees day-to-day operations of the Coalition and is funded by a grant administered by the Alaska Mental Health Trust.

The Coalition Case Manager is funded by a grant administered by the State of Alaska's Division of Behavioral Health. The Case Manager provides pre and post-release case management services to eligible individuals being released to the Anchorage community.
